5. Canal Case #04-2021 – Calvin Delisle – 22675 Bayview Dr. – Install (2) used Jet Ski hoists. Each hoist to be mounted on (1) 6" diameter piling.
6. Canal Case #05-2021 – Huron Pointe Excavating on behalf of Eric Rasmussen – 23268 Clairwood – Install 50' of new steel sheet pile 1' or less waterward of the existing steel bulkhead. Wall to be anchored with pipe anchors (to avoid removal of existing concrete walk adjacent to the existing seawall) 4 of the pipe anchors will be left high (582.0') to double as spring piles.
7. Lake Case #06-2021 – Great Lakes Seawall on behalf of John Rickel – 34054 Jefferson – Install 75' of seawall within 1' of existing seawall. Place 25 cubic yards of riprap at waterward toe once seawall is installed and prior to placing backfill. Backfill as needed with clean material from an upland source.
8. Canal Case #07-2021 – Great Lakes Docks and Decks on behalf of James Brockway – 22625 Bayview Dr – Install one 8' x 8' side lift hoist and one 15' x 11' cradle hoist.
9. Any other business that may properly come before the Board.
