NOTICE OF MEETING WATER RESOURCES & ADVISORY BOARD

There will be a meeting of the Water Resources & Advisory Board on November 10, 2020 at **7:00 p.m.** in the Jefferson Conference Room at City Hall, 27600 Jefferson Avenue, St. Clair Shores, Michigan.

The agenda will be as follows:

Canal Case #26-2020 – Huron Pointe Excavating on behalf of Thomas Loftus – 22539 Lange St. – Install 62.5 feet of new steel sheet pile 1 foot or less waterward of the existing steel bulkhead except at the proposed fill area, which is the existing boat well east of the garage. Fills will equal 31 cubic yards of clean material obtained from a commercial source. Remove and replace 2 existing piles.
6. Canal Case #27-2020 – Paradise Marine on behalf of Janette Rittenhouse – 22510 Beach – Install 35 linear feet of new steel sheet pile 1 foot less waterward of existing steel bulkhead. Install another 9 linear feet of sheeting at the west property line as a return. Backfill with clean material obtained from a commercial source.
7. Lake Case #28-2020 – Mark Fischer – 26818 Koerber – Close and fill current boat well, increase height of current boat dock and seawall, add two ice clusters, move / replace davit.
8. Canal Case #29-2020 – Bayside Marine Construction on behalf of Eric and Sue Russo – 22400 Bayview – Install 3 pipes in front of seawall to stop movement of bottom of seawall.
9. Lake Case #30-2020 – Bayside Marine Construction on behalf of Michigan Harbor Properties LLC – 24600 Jefferson – Install 728 feet of steel seawall and backfill. Remove 7 docks, install 6 docks.

10. Any other business that may properly come before the Board.
