**1. Call to Order**

**Fireworks**

Mr. Schwarzwaldner asked if it's the same three we've had in the past.

Mr. Bowman said yes. He said the Star Wars demonstration is from 8pm to 10pm and is \$850, the strolling magician is from 6pm to 9pm and is \$600, and the strolling jugglers is from 7pm to 10pm and is \$650.

Mr. Schwarzwaldner asked who watches to make sure these people are here until 10pm.

Mrs. Munger asked if we are going to open the park at 3pm. She mentioned that Jamie can go from 3pm to 6pm.

Mrs. Munger said she will have Miss St. Clair Shores there.

Mr. Bowman agreed.

### **Drive-In-Movie**

Mr. Bowman said we will have the first drive-in-movie on May 5<sup>th</sup> at the Veterans Memorial parking lot. He said the movie is the "Minions The Rise of Gru" and is sponsored by Michigan Credit Union.

### **Coney's for Kids**

Mr. Bowman said the Coney's for Kids fundraiser will be on July 19<sup>th</sup>. BBQ Daddy sponsors the hotdogs and Faygo sponsors the pop. He said the sponsorships are coming in real nice. He said Growing Smiles and Whistle Stop will most likely sponsor.

It was mentioned that Rock Star will be the band playing that night so it will be a good crowd.

Mr. Schwarzwald asked about the face painting.

Mr. Bowman replied that usually First State Bank provides face painting.

### **Farmers Market**

Mr. Bowman said Michigan United Credit Union sponsored the cooking show. He said the kid's entertainment is sponsored by Extra Credit Union. He is looking for sponsors for the yoga.

Mrs. Munger asked if we have a farmers market flyer out.

Mr. Bowman said we are finalizing it.

Mr. Schwarzwaldler asked about the money for the concerts.

Mr. Bowman said we needed more, but we are good.

Mr. Bowman said he will ask Petitpren in December what their commitment will be for next year.

Mr. Schwarzwaldler said he will start blasting the concerts on Facebook.

Mrs. Munger said she will start working on the National Anthem singers. She asked for a Music on the Lake flyer to be sent to members as well as the fireworks flyer.

Mr. Bowman said we'll have Chamber Concerts at Wahby Park the 2<sup>nd</sup> Monday in July to the end of August.

Mrs. Munger mentioned that the Tree Lighting will be December 1<sup>st</sup> and the Halloween in the Park will be October 22<sup>nd</sup>.
