They had until close of business last Thursday to submit their presentation. The order in which they will present was randomly selected previously by Administration. There will be no questions asked by Mayor or Council. Council members have reached out to the candidates directly prior to today. One applicant dropped out earlier in the appointment process.

The selection to fill Mr. Rubino's seat will occur at the August 17th City Council meeting.
